# A MESSAGE FROM THE PRESIDENT

Dear Cousins and Friends,

I am very grateful for the effort put forth by the Officers of this Association, and I wish to thank those members that participated in our 105th year of family gatherings. We had a good turnout for each of this year's program items, and our Vice-President, Frank Stevenson, must be congratulated. I believe you will find this year's program equally as interesting and varied. I look forward to meeting as many of our cousins as can attend these activities.

Past President Dorothy White, as Chairperson of the Lineage Book Committee, anticipates that the second volume of Roger Williams's children should go to press in the Spring of 1998. This book will cover the Freeborn (Williams) Hart line through eight generations. The third volume, encompassing seven generations of the Mary (Williams) Sayles line, is about half completed and may be available in 1999. An updated Mercy (Williams) Winsor volume is also being prepared and will extend through eight generations.

We are currently reviewing our Roger Williams Family Association artifacts, and will soon have a depository for the collection at Roger Williams University in Bristol, Rhode Island. These artifacts will be on loan to the University for safekeeping, with the Association retaining ownership.

In the interest of greater efficiency, we have created a master database that combines our members' names, addresses, and dues information. Because such a project requires up-to-date computer hardware and software, we are investigating the possibility of purchasing a good computer and high-quality printer. This system would be in the care of our Treasurer, A. John Prokopowicz, who is now overseeing the maintenance of the new database. As with any project of this size, there are bound to be errors in transferring information from one program to another. Should you notice such an error in your name or address, kindly bring it to the attention of Mr. Prokopowicz.

I have received with regret Miss Dorothy Budlong's resignation as Sunshine Chairperson. Miss Budlong has served the Association well for many years. In her place, I have appointed Mrs. Godfrey F. Allen of Riverside, Rhode Island. Her full address and telephone number are included on the back page of this publication.

Please note the dates and locations of this year's meetings on your calendar. As always, the Association solicits your thoughts and suggestions for future program items, and other ideas for improving our service to members.

Col. Robert Allen Greene President died at Newport in 1671 [error for 1670], and that his widow Mercy was allowed the use of the house, houselot and other lands; now she is about to Marry Samuel Winsor of Providence. (Waterman Family, Vol. III, p. 11, Donald Lines Jacobus and Edgar Francis Waterman, Hartford, CT 1954, citing Town Records of Providence)

3. Other sources and Town Records of Providence illustrate that the administration of Resolved's estate went on for many years. Before Mercy's marriage to Samuel Winsor in 1677, Winsor had petitioned the Court to allow the estate to pass to his future wife. Later, in 1681, Richard and Resolved Waterman, sons of Resolved and Mercy (Williams) Waterman, had a disagreement with their father-in-law [stepfather] over land left to them by their grandfather, Richard Waterman. (Waterman Family, Vol. III, citing Early Records of the Town of Providence, Vol. VI, pp. 34-37, 41-43)

We know Mercy (Williams) Waterman married Samuel Winsor 2 January 1676/77; and that her children by her first marriage were heirs of Resolved Waterman. Early Records of the Town of Providence also show that on 1 July 1679 Samuel Winsor and the orphans of Resolved Waterman

were taxed together 6s, 3d. (Vol. XV, pp. 207-211)

4. Bible records of Resolved Waterman's grandson, Benoni Waterman, born at Warwick 25 May 1701, died there 3 November 1787, state: "My father's name was John Waterman; my mother's maiden name was Anne Olney, daughter of Thomas Olney. My grandfather's name was Resolved Waterman, and grandmother's Christian name was Marcy, daughter of Mr. Roger Williams, the first settler in Providence. She had five children by my grandfather -- Richard, Resolved, John, Mary and Waite. After my grandfather died, Mr. Samuel Winsor married her and had three children -- Samuel, John and Hannah. My great grandfather's name was Richard -- he came from England with Roger Williams and my great grandmother's name was Bethia." (Greene Family of Rhode Island, Vol. I, p. 181, Louise Brownell Clarke, NY 1903; also partially quoted in Waterman Family, Vol. III, p. 11)

I hasten to add that we descendants of Roger Williams believe it unnecessary to prove the above marriages. We could cite many other sources which mention these marriages and the children resulting from them. I have used the above material simply because, except for Austin, it may not have been well studied. I note that Mr. Anderson in his "Biographical Note" on the same page as his "Comments" mentions LaFantasie's The Correspondence of Roger Williams. He might also have discovered the inclusion of Thomas Hart and Roger Williams's daughter, Hart, in this wonderful volume...

As a final defense of the legitimacy of the first marriages of Freeborn and Mercy Williams, it should be noted that all marriages performed but not previously reported to Town Clerks for recording, as required by law, were declared legal by an Act of the Rhode Island General Assembly in 1698:

"Be it enacted by this Assembly and the authority thereof, and it is hereby enacted, That all marriages that have been solemnized throughout this Collony, according to the laws of the Collony, shall, and are hereby declared to be lawfull and good in the law ..."

We have finally found a safe place for our artifacts, records, books, etc. Roger Williams University has graciously offered to take our material, on loan, for storage in their climate-controlled library depository. We have been in contact with their Librarian and their Archivist, who envision "The Roger Williams Collection." This collection will be available for research or browsing by our members during specified hours or by appointment.

We hope to have our material inventoried and ready for them by January 1998. If you have anything belonging to the Association, or if you have anything pertaining to Roger Williams or the Roger Williams Family Association that you would like to contribute to our collection, please get it to me soon as possible.

Thomas Casey Greene will take us on a tour of the *actual* birthplace of Gen. Nathanael Greene, Revolutionary War hero. This large colonial house with a central chimney was built in 1684 and was considerably remodeled in the 1860's. It was here that the General was born and lived for many years, running the iron works in the grist mill with his brothers, and it was here that the General's first child, George Washington Greene, was born. With good weather, members will be able to roam the grounds and view one of the original millstones and cast-iron artifacts from when

the forge was in operation. Following the tour, we will proceed down the road to the Greenwich Tavern for a business meeting and lunch.

# IN DEFENSE OF THE FIRST MARRIAGES OF FREEBORN AND MERCY WILLIAMS

Robert Charles Anderson in *The Great Migration Begins*, 1995, on page 2010 makes the following comments: "For two of the daughters of Roger Williams, evidence was not found for the marriage to the first husband (Freeborn to Thomas Hart and Mercy to Resolved Waterman), although both unions are confidently asserted in any number of modern publications. The rarity of the name Freeborn speaks in favor of the marriage to Thomas Hart, but additional information would be welcome in both instances. Assuming these first marriages, the evidence is more than adequate in each case for the marriage to the second husband."

We have felt it necessary to take a stand in support of the legality of these marriages, and we offer the following proof, which was part of our reply to a letter from a loyal descendant of Roger Williams:

20 September 1997

... The comments in The Great Migration Begins are unusual, considering the fact that most of the earliest marriages in Providence do not appear in Vital Records. At that time, marriages were civil rather than religious events. They were performed generally by Assistants to the General Assembly, or Assistants to the Town Council.

When taking the morals of that time into consideration, may we not agree that had Freeborn not actually married Thomas Hart, nor Mercy Resolved Waterman, those facts would have created a scandal of which we would have been well aware.

I cite the following facts to prove the authenticity of these marriages. I know that there are many more:

#### FREEBORN WILLIAMS

1. Roger Williams's letter to Gov. John Endicott at Boston, 1 December 1656:

"This bearer Mr. Hart a Young ship mr [master] (who now maketh love to my Second daughter Freeborne), is bound for Salem about a Vessell. If by his return You can spare a little season for a line, it shall be thankfully accepted by Your humble Servant." (Correspondence of Roger Williams, Vol. II, p. 474, Glenn W. LaFantasie, Editor, Providence 1988)

2. Roger Williams's letter to Samuel Hubbard at Newport, ca. Winter 1672/73:

"At present (to repay your kindness, and because you are studious, I pray you to request my brother Williams, or my son Providence, or my daughter Hart, to spare you the sight of a memorial in verse which I lately writ, in humble Thanksgiving unto God, for his great and wonderful deliverance to my son Providence) ... (Correspondence of Roger Williams, Vol. II, p. 688)

3. Thomas Hart of Newport (son of Edward of Providence) m. Freeborn Williams, daughter of Roger and Mary Williams. Thomas d. at Newport 1671, and in his will proved 7 Aug. 1671, he mentions his wife Freeborne and all four of his children. (Genealogical Dictionary of Rhode Island, p. 314, John Osborne Austin, Albany, NY 1887; reprinted Baltimore, MD 1995)

4. [425] William Brenton, etc. to freeborn hart. "Three and Twentieth day of [torn] ... 1674
Between William Brenton John Hull Benedict Arnold John Porter Samll Wilbur samll Wilson &
Thomas mumford of the one part & freeborn hart Executrix and widdow of Thomas hart Late of
Newport ... deceased ..." (Rhode Island Land Evidences, Vol. I, 1648-1696, p. 237, Genealogical
Publishing Co. 1897)
