# THE OLD BAPTIST MEETING HOUSE

The Stony Lane Baptist Church in North Kingstown, Rhode Island was founded in 1665 by Roger Williams, and is one of the oldest Baptist churches in America. The meeting house was built around 1710 and served the congregation faithfully for many years. The building slowly fell into disuse until, eventually, services and meetings were held there only several times a year. Members of the Roger Williams Family Association were among the few who visited the old meeting house during its lonely years, gathering there in 1937 for a joint meeting the members of the D.A.R. The Old Baptist Meeting House was revitalized in 1958 and saw weekly services for the next thirty years. However, a "New Baptist Meeting House" was dedicated in



1989, leaving the ancient little meeting house empty once more.

The following article, written by Mary Kenyon Huling and published in Roger Williams Family Association Bulletin No. 5, April 1944, relates the tale of that pleasant visit to the meeting house by members of the Roger Williams Family Association, Should anyone care to travel to "Narragansett Country" to see this quaint old building, turn left off Route 2 South onto Stony Lane, then right onto Old Baptist Road.

### The "Old Baptist" Meeting House in Stony Lane

North Kingstown has always been proud of its early association with Roger Williams. It was only through his courage and tactfulness that the new settlement was able to survive in the wild, Indian country. Great credit is also due Roger Williams for the pioneer, Christian seed-sowing in the community. Rhode Island historians say that Williams spent a good part of six years in the locality.

Richard Smith the first white settler, leased land from the Indians and established a trading post near Cocumcossoc brook and Williams soon built a house nearby. Of the 41 known letters written by Williams, 28 were written at Cocumcossoc. Williams sold his house to Smith in 1651, but often came back to preach to the settlers and to the Indians, who he was always anxious to Christianize. It is believed that he induced Elder Thomas Baker to come from Newport in 1666 and thoroughly organize a church and become its first pastor, of which he continued in charge until his death in 1710.

August 12, 1703, Alexander Huling deeded half an acre of land to the church society; "to make use for building a meeting house, for the service and worship of God." Sometime later a meeting house, that is still standing, was built on that land. In an old letter, dated May 20, 1750, mention is made of land given for the meeting house about 40 years before, and that it was built by subscription, but the exact date of its erection is not known.

If the "Old Baptist" meeting house in Stony Lane could tell the story of its past, it would add much to the history of the town. In the year 1771, there were 167 names on the Church member list.

For a great many years the church served the community faithfully, but with the building of more modern and centrally located churches in the town, the building has fallen into disuse. Occasionally it was opened for union services, which have always been well attended, or for Bible classes for people living nearby.

June 22, 1937 the Roger Williams Family Association were guests of honor of Pettaquamscutt Chapter D.A.R. at a meeting held in the venerable old building. The late Miss Abby P. Gardner, Regent of the Chapter, welcomed the guests who expressed their great pleasure at the opportunity to visit the historic meeting house. Mrs. Hilda Schuster, President of the Association, presided at the meeting. Rev. Gideon Burgess, one of the oldest members of the Society, read a poem by Roger Williams. A paper giving the history of the Church was read by the author. After a short business session, the assemblage went to the home of Miss Gardner in Wickford for a basket lunch. At 2 o'clock all went over to the Old Narragansett Church where they were met by the late Canon Herbert J. Piper, who was pastor of the church, and Miss Virginia White who was in colonial costume. Canon Piper gave a short talk on the history of the building, after which the group continued to the Cocumcossoc farm, the site of Richard Smith's trading post or block house. Mr. Austin Fox, the late owner, gave a history of the ancient house after which the party was taken on a tour of inspection and many things of interest were pointed out to them.

The old meeting house was the scene of a large gathering Sunday afternoon, October 17, 1943, when the long-planned-for marker, sponsored by Pettaquamscutt Chapter D.A.R., was dedicated. About 140 persons were seated in the 17 boxlike pews or standing outside near the door. Rev. Arthur C. Lambourne of Cambridge, Mass., a former pastor in the community, officiated. He was assisted by Rev. Stephen Talbott and Merith Kline, a divinity student. The congregation joined in singing several old hymns. Rev. Talbott read the 84th Psalm, beginning with the verse, "How amiable are Thy tabernacles, O Lord of Hosts."

"An Historic Church and an Historic Faith" was the theme of Rev. Lambourne's message, in which he pointed out the accomplishments of the historic church down through the years. Preceding Rev. Lambourne's address an historic sketch of the meeting house and the society who has occupied it was read.

Following the service the congregation assembled on the grounds about the meeting house. After singing "Faith of our Fathers," the plaque set in the panel over the door and bearing the inscription:

#### "OLD BAPTIST MEETING HOUSE, CHURCH ORGANIZED 1665"

was unveiled by three little girls, namely: Elizabeth Ann Schmidt, Joyce Lynne Huling and Rosemary Arnold, all descendants of Roger Williams, who held the first religious services in the community, of Richard Smith, at whose house they were held, and Alexander Huling, who gave the land for the meeting house. Appropriate services followed.

Roger Williams, who was prime mover in laying a deep and secure foundation for our State, was also prime mover in establishing the First Baptist Church in the Narragansett Country.

Members and guests are invited to meet at the Babcock-Smith House at 124 Granite Street in Westerly, RI for a tour of one of Rhode Island's important architectural and historical landmarks. The home of Dr. Joshua Babcock, born 1707, is an early Georgian style home. Dr. Babcock was Westerly's first physician, postmaster, and friend of Benjamin Franklin. He was also a General Assemblyman, Chief Justice of the Supreme Court of Rhode Island, and Major General of the Rhode Island Militia. Orlando Smith, a later owner, discovered granite on the property in 1846. Three generations of Smiths made Westerly one of the most important granite centers in the world. The cost of this enriching, marvelous tour is \$2.50 per person. After the tour we will meet in the newly-built carriage house for a business meeting and bring-your-own lunch. Directions: From Providence, Route 95 South to Route 4 South to Wakefield; exit to Route 1 South to Westerly and proceed all the way to 124 Granite Street (Route 1); take a right at Cumberland

Farms and park at the rear.

#### Saturday - October 13, 2001 at 11:00 a.m.

Members and guests are invited to meet at the Quonset Aviation Museum at 63 Eccleston Avenue in North Kingstown, RI for a tour of this working museum of commercial and military aviation. There are nearly 30 aircraft on display, including a Russian MIG-17, TBM Avenger, A-4 Skyhawk, A6 Intruder, and SH3 Seaking. Docents will lead the tour, which will last about 45 minutes, and will include information about naval history and the importance of Quonset Point throughout the years. To Chepachet: Left out of drive onto Paris Irons Road; left at "T" intersection onto Pound Road; right onto Route 102 North (Note the stone enclosure at the corner; built in 1749, it is the oldest town pound in America); straight-at "Stop" sign, continuing into Chepachet village; the restaurant is just after CVS on the right; park on the street in front of the restaurant or turn right into the driveway just after the restaurant to park in the rear lot (handicapped access at rear).

We will gather at First Baptist Church in America, 75 North Main Street, Providence, RI for our annual Founders' Day Sunday service. Following coffee and a tour of the historic Church, founded by Roger Williams in 1638, we will proceed to the home of Alice Cashill at 24 Meadowbrook Drive, Barrington, RI for a social hour and meeting. Please bring a picnic lunch and a lawn chair.

Directions: From Providence, Route 195 East to Route 114 South toward Barrington; left at light at "White Church" onto Massasoit Avenue and follow through to New Meadow Road; right onto New Meadow Road; first right onto Meadowbrook Drive; Cashill home is on the left.

Saturday - June 15, 2002 at 11:30 a.m.

Members and guests will meet at Bicentennial Farm, the homestead of the late Marion and Dorothy Fry, located in East Greenwich, RI. Once known as the Joseph Fry Farm, it features a 1795 farmhouse and an extensive rose garden that should be in full bloom at the time of our visit. Gladys Bailey, our Corresponding Secretary, will give our group a brief tour of this 19th century historical and agricultural gem. Following the tour, we will picnic on the grounds and hold our annual meeting. Please bring your own lunch and lawn chair.

Directions: From Providence, Route 95 South to Route 4 South; take first exit to Route 401, turning left at traffic light at end of exit; left onto Route 2 South; right into drive at 2153 South

County Trail at "Bicentennial Farm" sign.
