An interesting observation to note: I suspect many Cousins who receive this bulletin don't realize that our first President was Pardon Williams, who served from 1888 until 1905, a period of 17 years. Our Incorporation date is January 30, 1906 and quite often I mistakenly think that this date is when we started. I am including a list of all Past Presidents, and you will

note that our three year term limit started with our fourth President, Miss Paine.

I was born within days of the 300th anniversary of Roger's founding of Providence and at an early age I was shown Margaret's Rock, the shelter where Roger was nursed back to health after fleeing from Massachusetts during a frigid winter. While in high school, I teamed up with historian Ellis Gifford and we created a slideshow of abandoned historic sites, which were mostly in wooded areas from North Swansea, MA to Little Compton, RI. This early exposure to Roger's Shelter spurred me on to create a permanent marker at the site a few years ago and to pay homage there this year and on a bi-annual basis.

One of the main purposes of our Association is to perpetuate the outstanding legacy of our famous Grandfather, Roger Williams. As you know he was very passionate to correct the

wrongs of his day.

Some freedoms that Roger championed are being slowly eroded from our lives. One is Freedom of Conscience, our right to choose or not choose a type of religion along with a way of life expressing political dissent. ROGER WILLIAMS' TRADING POST

The June 1999 meeting of the Roger Williams Family Association was held at Smith's Castle at Cocumscussoc in North Kingstown, Rhode Island. It was a delightful afternoon, made special by a tour of the house and grounds led by knowledgeable guides in era costume and, later, a lovely picnic overlooking Mill Cove off Narragansett Bay. Also contributing to the afternoon's appeal was the knowledge that, somewhere nearby, Roger Williams conducted business from his trading post with the natives of the region.

As we sat in the shade and enjoyed the slight breeze off the water, some wondered where Roger Williams' trading post was actually located. Was it where Smith's Castle now stands? Was it the Vaughan House, as suggested by Elisha Potter? Or was it just across the road from Smith's Castle, either on the site of or still standing as the Hall-

Northup House?

To figure out the mystery, it's probably best to consult the extensive research done by Col. Elmer Hall Palmer, current owner of the Hall-Northup House. Col. Palmer states that, after laying out the town of Providence in 1636, Roger Williams "decided to establish a house on Narragansett Bay to trade with the Indians and to escape worldly life. This was accomplished some time after 28 October 1637, when the Chief Narragansett sachem, Canonicus, gave Williams a tract of land for a trading post. It seems likely, although not conclusive, that this trading post was located at Cocumscussoc by 1638, since a letter by Williams is dated 7 Sept. 1638 at Narragansett. However, the first direct mention of the trading post at the site comes from a letter from Williams to John Winthrop Jr. dated 28 May 1647 at 'Cawcawmsqussick.' At Cocumscussoc, Williams and his Indian servants raised goats and crops, hunted wild game, and engaged in the lucrative trade with the Narragansett Indians."

Roger Williams conducted business with the natives at his trading post in Cocumscussoc until 1651. It was in that year that, needing cash to finance a journey to England to deal with the Colony's charter, he sold his trading post to Richard Smith. For fifty pounds, Williams sold "my trading house at Narragansett, together with two Iron Guns or murderers, there Lyeing as alsoe my fields & fenceing about the s'd House, is alsoe the use of the little Island for goates which the old Sachem, deceased, Lent mee for

that use ..."

Once the property left Williams' hands, did it survive as the Vaughan House? As Col. Palmer states: "The Vaughan house location for Williams' trading post was proposed by Elisha Potter in 'The Early History of Narragansett' in which he reports that 'Wilkins Updike [1784-1867] says Williams' trading house was where Royal Vaughan

last lived next north of Spink's Tavern. John C. Reynolds lives there now.'

"This seems to be the least likely of the three possible locations. The reasons for this assessment are (1) the Vaughan house is too far from a harbor to be a logical choice for a trading post; (2) it is much closer to Maskechugg Brook than Cocumscussoc Brook, thereby making it illogical to call the settlement Cocumscussoc; and (3) the Vaughan house is located on property that was never owned by Richard Smith, Sr. who

bought Williams' trading house in 1651."

If not the Vaughan House, is the Hall-Northup House or grounds the site of Roger Williams' trading post? At one time, some must have thought so, for around 1936 the North Kingstown Committee of the Rhode Island and Providence Plantations Tricentenary Committee, Inc. placed a plaque on a rock near the driveway to the Hall-Northup House. The plaque was engraved: "In 1637 near this spot ROGER WILLIAMS set up a trading post where he dwelt for several years trading and treating with the Narragansett Indians. His dealings so completely won and held the friendliness of the powerful Narragansett Sachems that for more than a generation the white settlements of Rhode Island were spared to become a flourishing state."

The architecture of the Hall-Northup House lends itself to the belief that this was the actual trading post building. As Col. Palmer relates: "The core of the Hall-Northup House is a one-room, one-and-a-half-story stone ender, which is characteristic of midseventeenth century Rhode Island homes. On the basis of its architecture and general location in the vicinity of Cocumscussoc, both Norman Isham and Antoinette Downing (1979) have suggested that 'if it were not that the chronicles of King Philip's War of 1675/76 record the destruction of every building south of Warwick, one would have to conclude that this is Roger Williams' trading post of ca. 1638.' It is possible that after King Philip's War the house was rebuilt on the foundation of the earlier structure, encompassing remains of the stone ender which may have been Williams' trading house."

Granting that the Hall-Northup House was destroyed during King Philip's War. was it at least the site of Roger Williams' trading post? Col. Palmer, borrowing from the work of Patricia E. Ruberstone (1990), Principal Investigator in her report with Robert K. Fitts, states that it was not. "... this house could not have been sold to Smith by Williams in 1651. Extensive deed and genealogical research showed that the house remained within the Hall family for the entire 18th C., and that the first Hall owner, William Hall, left his sons in his 1673 will 'all my land in the Narragansett which I purchased of Thomas Lawton.' Thomas Lawton purchased this tract from the Narragansett sachem Cadganaquant in 1660, but the exact location of this tract has not been identified. The tract is described as being 'bounded on the north and west with a river called Signebetuck together with all the mowable land bordering on its north and west sides of the said river, on the south bounded by an Indian path called Mascopoumsicke, on the east with the English path from Warwick to Pequot.' Assuming that the land purchased from Lawton is the same on which the house now stands, this land was never owned by Richard Smith and thus could not have been sold to him by Williams in 1651. Thus the Hall-Northup house does not seem to be the site of Williams' trading post."

The only remaining and most likely candidate for the site of Roger Williams' trading post is, therefore, the area surrounding Smith's Castle. Col. Palmer states: "According to the 'Petition From The Inhabitants Of The Narragansett Country To The King' in 1679 Smith may have moved into Williams' house after 1651 and built around it. This suggests that Williams' trading post would be in close proximity to the block house in which the Colonial troops were garrisoned in 1675, although it may not be on land presently owned by the Cocumscussoc Assoc. since the Updike lands were subdivided in the early 20th century." As stated in Roger Williams Family Association Bulletin No. 52, when Richard Smith took possession of Williams' trading post and property in 1651, he decided that it was there he would "put up his 'English Home.' In 1676 Indians burned the trading post and garrison house, but Richard Smith, Jr. erected in 1680, partly from material of the old building, the house which stands today at Cocumscussoc Farm."

The June 2000 meeting of the Roger Williams Family Association will be hosted

by Col. and Mrs. Elmer Hall-Palmer at the Hall-Northup House at Cocumscussoc. Perhaps one should take this opportunity to peruse the Hall-Northup House and grounds, then peer across the road to Smith's Castle ... and wonder.

SATURDAY, NOVEMBER 7, 2015 - 1:00 PM (Rain Date November 8 at 1:00 PM) BIANNUAL PILGRIMAGE TO THE ROGER WILLIAMS SHELTER

We will assemble on the straight dirt road off Birch Swamp Road, Warren, RI and travel by car to within several hundred yards of the large overhanging rock shelter known as Margaret's Rock in North Swansea, MA. Margaret was a Wamponoag Medicine Woman who helped Roger return to good health, along with the help of Massasoit, following Roger's banishment from Massachusetts Bay Colony in that very cold winter of 1636. Our RWFA Bulletin of June 1953 states, "He was sick and exhausted and an Indian Squaw, later identified as Margaret, took care of him until he could resume his journey." Famed historian, J. Earl Clauson detailed this location, known as Roger Williams Cave, in a 1940's Providence Journal article. It is the only abode which exists today in the Providence area whose walls Roger actually touched. Let us pay homage to this temporary and first home in the wilderness for Roger during the 14 weeks immediately after his banishment.

Directions: From Providence, take Rte 195 towards Swansea/Fall River. In North Swansea, exit to Rte 136 and travel south 1.7 miles. After crossing into RI, take a left onto Birch Swamp Road. Continue for 0.3 miles where the road takes a 90 degree turn to the south. At this bend go straight onto dirt road at "Windswept Farm" sign. DO NOT turn right into drive to the old Chase Farm. We will start assembling on this first dirt road shortly after 12:30 PM. A group

Follow Rte 102S to the junction of Rte 100 in Chepachet. Turn right onto Rte 100 at stop sign. Continue on Rte 100 into the village of Pascoag. Turn left at stop sign (Dunkin' Donuts will be on your left). Take the next right midway up the hill onto Church Street. Take second right (the streets are right next to each other and go on either side of the school) after Serio's. There will be a parking lot behind the school on your right.
